

The SN54F20 is characterized for operation over the full military temperature range of -55°C to 125°C . The SN74F20 is characterized for operation from 0°C to 70°C .






SN54F20 . . . FK PACKAGE
(TOP VIEW)





(6) Lead/Ball Finish - Orderable Devices may have multiple material finish options. Finish options are separated by a vertical ruled line. Lead/Ball Finish values may wrap to two lines if the finish value exceeds the maximum column width.

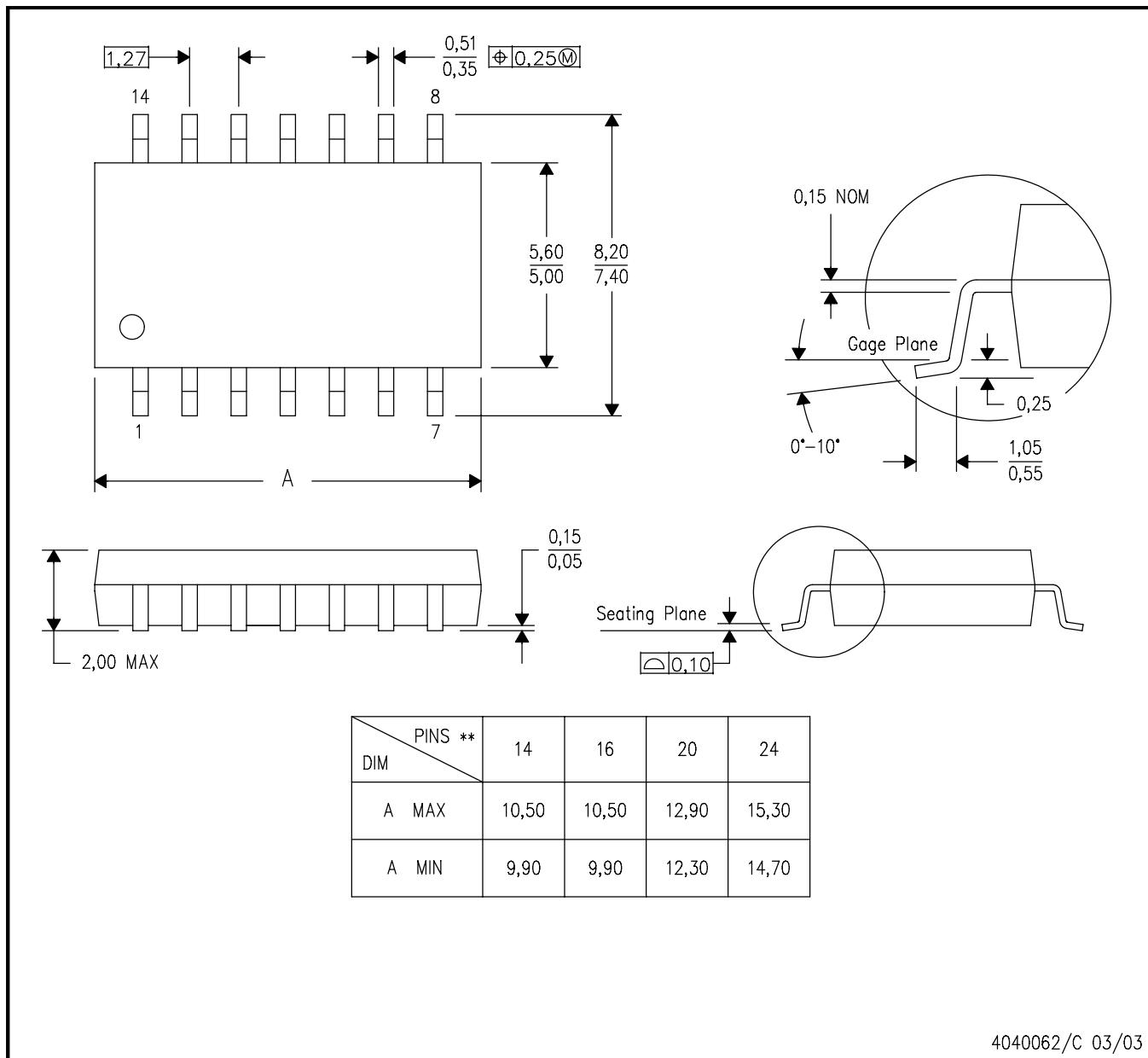

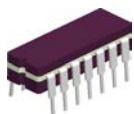



CERAMIC DUAL IN LINE PACKAGE




LAND PATTERN EXAMPLE



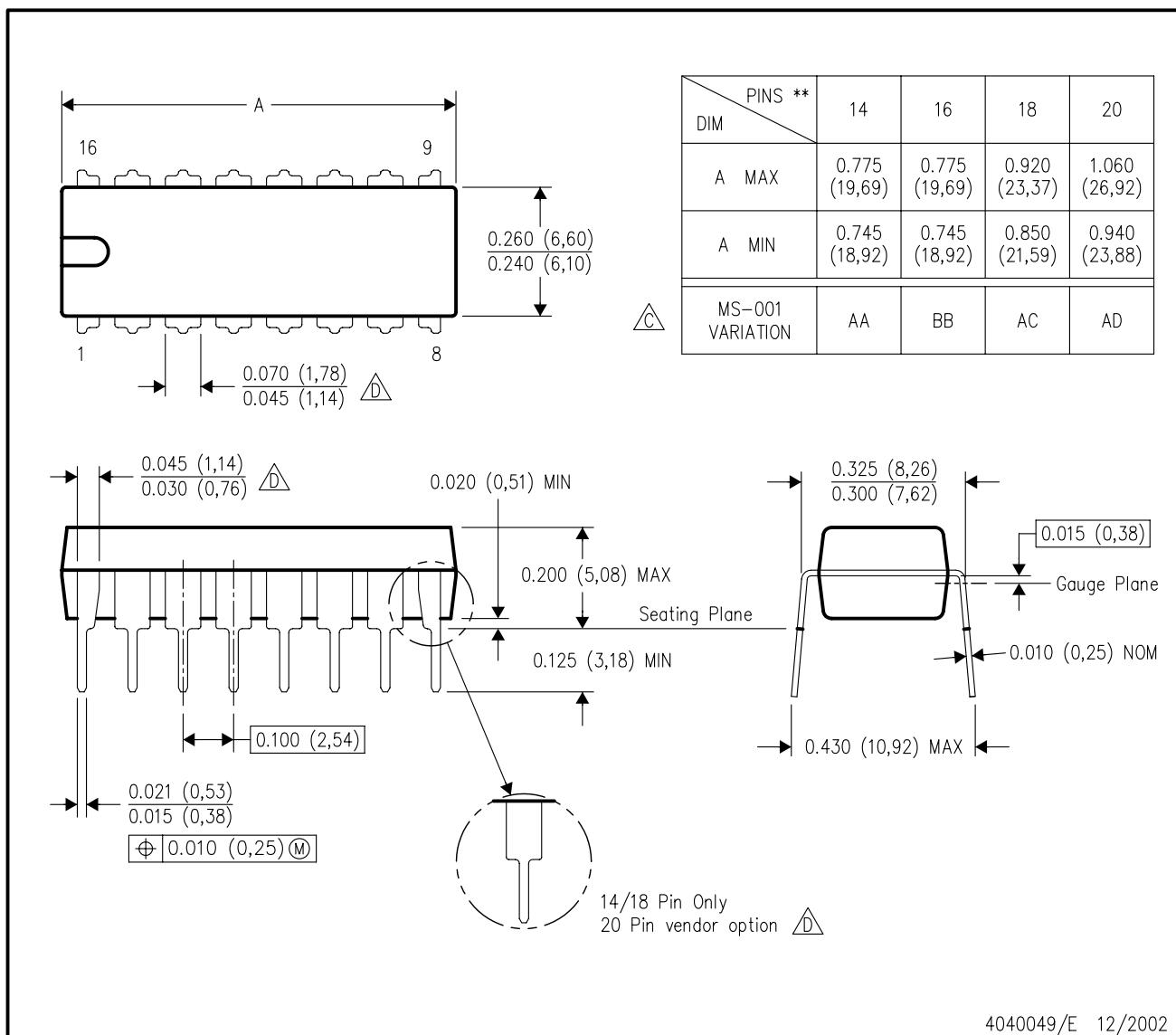
